Trail User 14 Year Study

- ** The Connecticut Horse Council (CHC) partnered with Dept. of Energy & Environmental Protection (DEEP) in 2003 to create the Volunteer Horse Patrol (VHP) to ride and serve in state parks & forests.
- * The establishment of this Patrol Unit came to fruition for Connecticut when drastic cuts on our state budget caused layoffs, along with staff & supervisor reductions. That situation forced the closure of many state parks & forests and reduced services because of this lack of state funding. This situation still continues with the DEEP today.
- * This program helps to protect and preserve the trails of the state. Since its beginning, the Patrol expanded to include, land trusts, open spaces, town lands, city parks and private lands.

Trail User 14 Year Study



- The primary responsibility is to serve as auxiliary "eyes and ears" for the protection of the resource and its visitors -- on the lookout for what is going on out on the trails.
- * By providing a community service to land owners in exchange for usage of the lands creates a win- win situation by providing trail patrols and maintenance at no cost.
- During the 14 year period, members recorded statistics pertaining to the activities they encountered, volunteer patrol & trail maintenance hours, along with assistance given to other trail users, including information, education on trail etiquette, directions to lost persons and first aid.

Shocking Statistics

- * 15 year history
- * 38,043 hours of patrol over 14 years
- * 88 areas throughout the state
- * 14-year statistics collected from:
 - 21 state forests
 - 28 state parks
 - 7 Wildlife Management Areas
 - 9 land trusts
 - 15 town and open spaces
 - 8 private lands



Patrols and Value

* Members contributed 37,980 hours of patrols and trail maintenance, and also donated the use of their equipment, including chainsaws and tractors

** The Independent Sector valued volunteer time at \$19.50 per hour, for a total of \$740,610 in volunteer service contributed by VHP members over the 14

year period from 2003-2016



Volunteer Horse Patrol Contributions

- ** There were between 50-100 members of the patrol over each of the past 14 years
- * 30-40% of these members submitted reports on patrols and trail maintenance
- * VHP members gave directions 380 times
- * VHP members provided general information 6,598 times

Horses on Trails

- * Collected data show a large number of horses utilize state, town, and private lands, and work to patrol and maintain trails
- * 27.7% of trail users recorded were equestrians

27.7%

- ** Over the 14-year period there were 33,357 horses out on the trail during the patrols and an average of 1.75 other horses per patrol
- * 30% of the 8,279 trail users recorded by the VHP in 2016 were equestrians



Volunteer Horse Patrol – Dog Walkers

- * The highest number of walkers and dogs were reported in 2009 the year with the highest number of patrols
- * Most dog walkers (74%) were in compliance with the law that dogs need to be leashed



Volunteer Horse Patrols

- * The number of patrols totaled 19,106. The average length of patrol hours varied over the years, for example 1.5 hours per patrol in 2010, versus 2 hours in 2011
- * There were fewer patrols in 2011, although members spent more time on the trail during each patrol.



Recorded Visitors without Motorbikes or ATVs 2003-2016




