The coverage is from January 1st to December 31st 2019, so it is best to send in the annual fee along with your CHC membership dues as early as possible. The insurance is \$19.00 for an individual and \$38.00 for family. See pages 4-5 for more information

Frequently Asked Questions

about the Personal Excess Liability Insurance administered by Equisure, Inc. for Association Resource Group (ARG) and their affiliates

THIS INSURANCE IS EXCESS AND NOT INTENDED TO BE YOUR PRIMARY EQUESTRIAN LIABILITY COVERAGE.

- When does my personal excess insurance start and end? The coverage starts when your membership is approved and the premium is paid to Equisure. Coverage ends 12:01 am on December 31st of every calendar year.
- If my membership starts in June, when will my insurance coverage start? Your coverage will start the month and day you purchase your membership. For example, you will have coverage for approximately 7 months if you joined in June and coverage for 12 months if you joined in January. In both cases the coverage will end 12:01 am on December 31st.
- How can I get a copy of the Master Policy? Contact Equisure directly with proof of your membership and request a copy of the Master Policy or email your request to info@equisure-inc.com. The Master Policy may not be posted on your association/club websites or reproduced without prior written consent from the management of Equisure.
- **Do members get anything showing proof of coverage?** Yes. Your club/association will be provided with certificates of Insurance (a brief summary of coverages, conditions and exclusions) these may be distributed only to members. Like the Master Policy, the Certificate of Insurance may not to be posted on websites or reproduced in any fashion without written consent from Equisure.
- How would this insurance apply if I have homeowners insurance? This policy is excess over any other valid and collectible underlying insurance. If you have underlying insurance, such as homeowners/farm insurance, this policy is excess over that insurance. If you have no other underlying insurance this policy would become primary.
- I am a trainer and run a horse breeding operation, does this insurance provide coverage for my business? No. Coverage for equestrian businesses and business related activities are excluded from the personal excess policy. Please contact Equisure for more information or to purchase Professional and/or General Liability insurance for your equine training activity and/or any other equine business operation.
- If my horse is boarded away from my residence, would this policy provide coverage? Coverage could apply, on an excess basis, any other insurance policy is primary. This policy provides coverage for equine related incidences away from your residence for which you are personally liable or negligent.

- If I lend my horse to someone to ride, how would coverage apply? This policy would be excess but you would have coverage for bodily injury and/or property damage to a third party for an equine related incident caused by a horse you own for which you are held legally liable.
- Is my horse covered if it dies? No. This policy does not provide animal mortality coverage for horses you own. **Equine Mortality/Major Medical Insurance** can be purchased by calling Equisure (800-752-2472) or internet quote request at **www.equisure-inc.com**.
- How are insureds defined? Family Membership: includes "you", your resident spouse and your children under 18 years of age. The each occurrence limit is the most we will pay for the sum of damages claimed against you, your resident spouse and your resident children under 18 years of age.

Individual Membership: The Each Occurrence Limit is the most we will pay for the sum of damages claimed against you (the member) arising out of one occurrence.

For any claim to be considered, the member(s) must have a valid membership and be in good standing with the affiliate association/club of Association Resource Group. The General Aggregate limit is the most we will pay for the sum of all damages claimed.

- If I fall off my horse and broke my arm, would this policy provide coverage? No, not under the Personal Excess Policy. This is not a medical insurance policy. You would need to have your own health or accident insuran
- What limits are provided by this policy? The limits provided under this policy per household and is shared by all member of the same residence: \$1,000,000 aggregate limit ~ \$1,000,000 per occurrence limit
- **2** Can I increase the limits provided by this policy? No.
- **Can I add an additional insured to this policy?** This policy provides personal excess liability insurance for you. It does not allow for the addition of additional insureds. If needed, you can purchase Primary Equine Liability insurance for owned horses on a primary basis and add an additional insured.
- What should I do if I think I have a claim? 1. Immediately document all the details about the incident 2. Get the names and phone numbers of any witness(es) 3. Do not admit fault or make any monetary payment 4. Contact Equisure at 800-752-2472.

Legislation

The Legislative Assembly is now in session. If any upcoming bills pertaining to our equine industry or public lands we will notify you and ask you to contact your legislators.

Watch out for Update on Passport to the Parks: As you know Passport to the Parks was passed, but sadly some language in the Passport to Parks authorization allows the General Assembly to consider \$2.6 million in year 1 and \$5 million in year 2 of the Passport funds be considered "surplus." The CHC will be working with the CT Forest & Park Association in 2019 to get the Passport to Parks funding to go to Parks and not "surplus" (a.k.a., the General Fund).

Connecticut Constitution Amendment Passed

You did it! Your vote "YES" in this past election created an amendment to our state constitution. This amendment now requires that State-owned public lands must receive a public hearing and a two-thirds vote before being given away, swapped, or sold by an act of the General Assembly. **THANK YOU**

Bond Commission Update: 3 million dollars was allocated for the National Recreation Trails Program (RTP). The Grant Round for 2018-2019 was opened and the last day of submission was October 31, 2018. Stay tuned for the 2020 grant application. For more information

Trails Report

Natchaug State Forest - Lost Silver Mine Horse Camp

The campground is still closed due to dead and falling trees and will probably be closed for the 2019 year. You can park at a small lot just before entering the camp. Trails are still open, but you need to be aware of the dangers.

Thank you to CT Forest & Park Association member Dave Raczkowski who reported that he did clearing on the trails in Natchaug and Goodwin Forest.

Pachaug State Forest - Griswold

Gov. Ned Lamont revealed that the state has abandoned plans to locate a state police gun range in Griswold. during a press conference at the State Capitol in Hartford.

The state had considered locating a 55,000-square-foot range on a 113-acre parcel near Pachaug State Forest, sparking opposition among Griswold residents concerned about noise from such a facility. Equestrians also got involved to get this project ousted since it would affect riding in the forest and camping at the Frog Hollow Horse Camp.



Members of the Connecticut Greenways Council are appointed by the Governor and the leaders of the General Assembly. Their duties include advising and assisting in the coordination of state agencies, municipalities, regional planning organizations and private citizens in voluntarily planning and implementing a system of greenways; providing assistance to state agencies, municipalities, regional planning organizations and private citizens in the technical aspects of planning, designing and implementing greenways, including advice on securing state, federal and nongovernmental grants; and establishing criteria for designation of greenways. Many Council members have had direct experience with trail and greenway development, and they can provide valuable insight into the development of successful local and regional projects.

The Council solicits nominations every February for official state greenway designation. Potential applicants are welcome to submit pre-proposals anytime to allow for discussions with CGC members and facilitation of new greenway designations when appropriate.

The council also reviews applications and awards grants submitted for the Recreational Trails Program.

Our CHC Representative is Stacey Stearns.

The Passing of Ginger Tullai







Ginger represented equestrians in the Second Congressional District appointed by the President Pro Tempore on the CT Equine Advisory Council from 2016-2018.

Ginger will always be remembered for her volunteer work as a member of the CT Horse Council since 2006. She served on the CHC Trails Committee and was the Area Coordinator for the CT Horse Council's Volunteer Horse Patrol Program. She oversaw two very large DEEP areas – Gillette Castle and Salmon River. These included 3 state forests, 8 state parks and 3 Wildlife Management Areas. She logged over 1,500 hours on VHP patrols.

Ginger was also instrumental in establishing "The Friends of Machimoodus/Sunrise Resort State Park and served as Vice president for the group. Among many things that she has done in this position was to promote horse camping at this park and organized two camping events these past couple of years. This I believe was one of her favorite places and wanted others to share in the beauty of this land. I know she would love us all to continue on with her work to make this happen.

In the 12 short years we had Ginger in CHC, she dedicated countless volunteer hours to promote and support equestrian use. She was instrumental in getting the Comstock Covered Bridge in the Salmon River State Forest in East Hampton modified so that horses could access both sides of the forest and was working on getting a multi-use loop trail system marked in the forest. Her volunteer services provide representation of the state's equestrian community on state and local levels, educating individuals, groups, and professional organizations of the importance of protecting and preserving trails and open space, while promoting equestrian use on our trail systems and Greenways and its economic and health benefits available to the community.

She was also a member of the CT Farm Bureau and several other horse organizations. She served as secretary and vice president of the Greener Pastures Rescue in Salem.

Many of you may also know her through her membership to the CT Trail Rides Association (CTRA) and an Area Vice President. She has guided many trail rides through several forests and parks, so that others may learn and enjoy the trails.

All of us who know Ginger will always have special and fond memories. On behalf of all equestrian groups, we celebrate Ginger's life and her accomplishments, thank her for her dedicated service and wish her HAPPY TRAILS ahead. We Love you Ginger - you live on in our hearts.

Horse Owner's Corner: Timely Tips – Fire Prevention Dr. Jenifer Nadeau, UConn Equine Extension Specialist and CHC Education Chair

Fire safety may not be a thought on every horse owner's mind, but it should be in order to prevent tragedy from occurring. It seems like every horse owner knows stories of horrific barn fires and you certainly don't want to be the next one! The burning rate of loose straw is 3 times that of gasoline. The burning time of a 12' by 12' stall is approximately 90 seconds. You have 30 seconds to get a horse from a stall after the stall ignites, so start planning what to do NOW! There are three major aspects to fire safety: prevention, preparation for fire, and action to take when a fire occurs. This newsletter, we will focus on prevention!

There are many ways to prevent a fire from occurring:

- **Keep the inside of the barn clean.** Fires need fuel to burn. Avoid piling up garbage, accumulating loose hay, bedding, baling twine, cobwebs, dust, and allowing birds to nest in the barn. Keep aisles clear and make a separate room for all tools and related objects, including wheelbarrows and buckets, which can become a safety hazard in an emergency.
- **Keep the exterior of the barn clean and neat**. Make sure it is free of combustible materials. Keep the lawn near the barn mowed and trimmed, since tall grass can ignite and spread to the barn.
- Be accessible to emergency equipment. Make sure that your driveway is clearly marked and your address is clearly visible in a prominent location. In the event of a fire, be sure that gates are open and wide enough for fire trucks to drive through. Keep overhanging branches cleared near the driveway so that fire trucks can have unobstructed access.
- **Properly use electricity**. Never use plastic coated wire. Use conduit or metal clad cable which is the safest electrical installation. Never overload fuses. Use heavy weight extension cords, and enclose light fixtures, especially incandescent bulbs, within safety shields.
- Watch all stored hay for development of heat. Never take a chance with wet or green hay. Spontaneous combustion is not an old wives' tale. Ideally you should store hay separate from the barn, with only small quantities kept in the barn at any time.
- Never store volatile or flammable material in the barn. This includes paints, gasoline, and oil. Don't collect old paint rags and brushes in the barn.
- **NO SMOKING in the barn.** If you have confirmed smokers on staff you should designate a smoking area away from the barn. Put up "NO SMOKING" signs.
- **Use the proper heaters.** Use only code approved, permanently installed electric heaters, and NEVER use portable space heaters.
- Have an independent inspection of the barn by an electrician. The electrician will confirm the safety of electrical devices and wiring. The number one cause of barn fires is electrical issues.
- Have an inspection of the barn by your fire chief. The fire chief will give you a fire prevention point of view. Listen, take advice, and act on everything that is reasonably possible. Now is a good time to think about how to prevent fire in your barn. Hopefully this will give you some ideas about ways to protect your horses.
