





The Volunteer Horse Patrol serves the community by providing data to the state Department of Energy and Environmental Protection, and helping other user groups with general information, directions, and first aid.

Continued education and dialogue between all trail user groups (such as trail etiquette about how all user groups can safely interact on the trail) is crucial as more of us share fewer recreational trails. The Connecticut Horse Council created the Volunteer Horse Patrol (VHP) in 2003 to assist the state during a time of economic hardship. This service provides CHC, DEEP and other Land Management Areas with information on how the equestrian community is continuing its effort to maintain trails for multiple use, while promoting and educating the community and other equestrians of our volunteer efforts.

The VHP has come a long way from its small start in 2003 of 5 patrol areas to over 100 areas around the state, including town parks, open spaces and land trusts. As we continue to grow, we are expanding our riding opportunities and helping to create long distance connecting trails.

Members patrol local and other areas they are able to get to. There are no required hours – we ask that you log the hours you do ride so that they are included in our total that we submit to DEEP at the end of every year. The CHC-VHP provides safety vests that identify volunteers. Your membership is \$20.00 a year to the CHC. Members are asked to get certified with CPR & First Aid on their own.

### CONNECTICUT EQUINE ADVISORY COUNCIL



The Connecticut Equine Advisory Council was established on May 22, 2007 by [Public Act 07-42](#) to assist the Department of Energy and Environmental Protection with issues related to the preservation of equine trails in the state.

**Membership:** The council consists of the president of the Connecticut Horse Council and five representatives from organizations that serve the horse industry within each congressional district statewide in addition to one member of the Connecticut Forests and Parks Association, appointed by the minority leader of the Senate.

The mission of the Equine Advisory Council and is to promote equestrian use on public lands, creating, preserving, maintaining and restoring trails.

- The Merritt Parkway Greenway. This will be part of the East Coast Greenway. Greenwich is looking to design their section of the trail in hopes that others will follow along with the design.
- The Council will be voting on Grant applications and planning the 2026 Fall Trails Symposium.

**Pre-Harvest Site Walk DEEP Pre-Harvest Site Walk - 1/30/26** - DEEP Forestry will host a pre-harvest site walk at **3 PM on Friday, January 30<sup>th</sup>**. CHC received notice from Daniel Evans, DEEP Forestry Division of a commercial harvest to occur in James L. Goodwin State Forest in 2026. The 36-acre harvest, prescribed in the DEEP-approved management plan for the forest, will be initiated with the goal of restoring oak forest in an area substantially impacted by spongy moth defoliations and subsequent mortality of upper canopy oaks. The prescribed shelterwood harvest will retain the healthiest seed-producing oaks while removing slower growing, poorly formed, and suppressed trees preferentially. The harvest will create a two-aged forest structure supporting a widely spaced age-class of large diameter dominant oaks while allocating growing space in the forest understory for a new age-class of tree and shrub regeneration from seed and sprouts. Eight-acres of the harvest area will be clear cut and enclosed with a “slash wall” to prohibit white-tailed deer browse and demonstrate the effects targeted deer browse can have on early forest stand development. DEEP feels this demonstration of an emerging forestry concept is well-aligned with the donor goals of James L. Goodwin who specified education and demonstration as key components to DEEP’s management of the forest.

The harvest will remove roughly 84,000 board-feet of sawtimber and over 200-cords of firewood. The work will be carried out by a licensed logging contractor, under the direct monitoring of a DEEP State Lands Forester. The project may take anywhere from 6-months to 1-year+ to complete.

## Legislation / Reports / Updates:

- Discussion on E-bikes and incident in Newtown. CHC will work to educate towns on the new law and their responsibility. Ann Marie & Diane will work on getting this out to towns.

**NOTE:** Bill # 7160 was passed into law. It allows for no modifications on the E bikes: the speed limit is left to the towns and no person under 16 can operate an E bike. A person can be charged with a moving violation riding an E bike and no head gear is required. The individual towns are left to regulate the E bikes.

- Discussion also on issues bike users on the Airline and loose dogs at Machimoodus State Park.
- Denise Ciano reports that she still has not heard from Senator Bob Duff on her appointment. CHC and EAC letters will be sent again asking Senator BOB Duff. to address the ongoing issue of not appointing someone for the 5<sup>th</sup> District equestrian representative on the EAC.
- Recommendation letters from EAC and CHC were sent asking Governor Lamont to appoint Ann Marie Seavy-Cioffi to the CT Greenways Council.

### ***Kim Bradley DEEP Reports:***

**Recreational Trail Grant Round:** The 2025 CT Recreational Trail Grant round closed on December 18, 2025. Seventy-three external applications and two internal CT DEEP funding requests were received, with over totaling over \$ 20.17 million in requests (this total does NOT include an administrative percentage value). The review process has begun; formal allocation of the Bond Commission funds has not occurred and may be requested following application review.

## State Park & Forest Trail Reports / Updates:

**Meeting Highlights.** The following reports are from the recent CHC meeting on December 2, 2025 and CT Equine Advisory Council (EAC) on **January 8, 2026**.

### ***Diane Ciano Reports:***

**Larkin Bridle Trail:** Kowboy Ken and myself met with Oxford officials and a representative from Joyce Trucking regarding getting access to the lot on Christian Street. The lot is leased by Joyce from DEEP.

We discussed how trailer parking for horses can be used again. There was an incident where a horse trailer parked blocked a truck from leaving the parking area for hours which cost the company considerable money.

We also discussed signage for No parking at the adjacent lot, closing of the gate at the pull through lot, along with opening up the old trail behind the lot so that horses can safely access the Larkin Bridle Trail - avoiding riding along Christian Street.

A few weeks later, Ken met with Mr. Joyce. The CHC sent a letter thanking him. We will work on getting the signs done, perhaps a kiosk and finding a volunteer group to clear the trail before we let the equestrian community know it's available for use.

- *Kim Bradley: Suggested we notify Lindsay Suhr – DEEP Land Acquisition and Management Office Director to let her know about this so that when the lease is up - the DEEP can take this over as an official parking lot for horse trailers. This would also be a time to contact her on the “Passive Recreation” definition that does not include horses.*

**Diane:** *I talked with DEEP Jeff Dery, Unit Supervisor. He said that those piles of dirt reported was stoned dust and as it rains and packs down, you'll see more of the stone dust. I told him there were some low spots that could use some more and he said when he had time he would do that. He also mentioned about*

work on the Towantic Hill Rd Hill section and that it needs more engineering to get the water to drain off the trail, but there is talk on getting it done.

I also mentioned to him about the Naugatuck State Forest parking lot in Oxford. He said there is talk about it but right now the power company is in there. He said to send an estimate and idea of what we wanted on the parking lot. I told him we could apply for a grant if DEEP will approve it.

- **Kim Bradley DEEP Reports:**

**Larkin Trail:** CT DEEP staff have been meeting internally to move the design work ahead. SLR Consulting Engineers are officially under contract and have completed detailed technical field work for the trail's long-term repairs. There will be opportunities for public input, it is worth providing any recommendations for surfacing materials and designs that support equestrian access.

**Ruth Strontzer Reports:**

**Machimoodus/ Sunrise SP:** The trails appear to be kept in good shape by Ray. Loose dogs are still an issue but the several I ran into the owners had good recall and there was no issue with them and the horses. I had a second sighting of a bear but with the bells on the horses again it moved off in front of us down the trail and then off into the woods. It was in the general area where we had spotted one before. No ear tags that I could see. At some point I'm afraid it will run into some of the off-leash dogs which may not end well.

**Wadsworth Falls SP:** Trails seem to be in good shape but there is a massive amount of downed dead wood in the park and there is a potential for a wild fire. CTRA held a ride there in November and Martin had offered to open the area under the pines for horse trailer parking. I called and made the arrangements. it worked out perfect the gates were opened prior to the first trailer arriving. With both gates open it became a drive through and there was no backing or turning rigs around. 13 trucks and trailers were parked there which opened the parking lot to the General public kept people away from the horses and rigs and turned out to be a win for everyone. Pictures were sent to Martin that day of the trucks parked there and a big thank you for offering it. Attaching a couple of pictures to this report.

**Chatfield Hollow SP:** – The trails and dirt roads seem to be in good shape but ran into a lot of dogs off leash there again. The covered bridge has been rebuilt but when I was there. It was taped off.

**Hurd SP:** What trails I was able to ride seemed to be in good shape I was there Dec 1st and the main gate was already locked. In the past had been left open until into Jan for hunters to go down into the

**Higganum Meadow WMA:**

**Hurd SP** – What trails I was able to ride seemed to be in good shape I was there Dec 1st and the main gate to Hurd was already locked. In the past during hunting season that gate had been left open until into Jan for hunters to go into the Hurd in order to reach the Higganum Meadow WMA to hunt.

Riding in Hurd we found that there were several trees with damage from beavers on the red trail that runs along the river. So far nothing has dropped on to the trail. Little guy has big ambitions if he is planning to dam the CT River.

**Note:** The Higganum Meadow WMA shares boundaries with Hurd and the George Dudley Seymour SP

**Meg Sautter Reports:** For the 3-month period of Oct thru Dec 2025, I did not ride at all. I hiked Cedar Mountain in Newington and did lots of clipping and clearing. Reported the guy living in a tent to the PD. PD told him to vacate. As of January 2026, he is still there.

**Mooween SP:** The new parking lot is great and will accommodate horse trailers.

***Vevette Greenberg Reports:*****Larkin Bridle Trail**

Rode the Larkin trail on Sunday December 21<sup>st</sup>. From Christian Street to Wooster. The trail was in good shape. The ladies I rode with were very pleased with the repair we did to the private part of the Larkin Trail at Towantic Hill Road. We also rode some of the Larkin trails off of the bridle trail. I was surprised we did not come across any fallen trees. We had some high winds just a few days before that.

Big thanks to Diane and Kowboy Ken, They went and met with the First selectman and also ran into a man from Joyce Trucking. He told them the property was owned by the DEEP. I found that funny that the town land records say it is owned by Town of Oxford. Also, that the secretary wanted us to give her all this info so the first selectman could do some research before meeting with us. (which has taken almost 2 years) Clearly he never did, because even he didn't know it was not owner by the town. The end results is, we can use the lot for horse trailer parking. But they will continue to keep the gate chained but not locked.

**Naugatuck Forest**

In October I rode the Naugatuck Forest trails around the reservoirs. They were also in good shape. Met three hunters that told me they were hunting Squirrels. They were courteous and did not shoot while I was nearby.

***Danielle Borrelli Reports:***

The only Trail report that I have is for Chatfield Hollow because I went there on Saturday. The main road was mostly clear of snow, although I'm assuming by now it should be fully clear. Some of the smaller back trails (that probably wouldn't be too good for horses anyway) had tree trees down on the blue and white trails. Buck Road was clear as was the road by the swamp, Schubert Rd. Both were covered in snow and some slippery spots while I was there but again with the warmer temps this week. I'm sure they're clearing out nicely.

**Old Business - Follow Up****Go over CHC Goals presented to DEEP in 2024: *Where are the CHC requests on DEEP Priority List?***

- Horse trailer parking to accommodate equestrians. Trailer Parking – Gave list of parks and forests that need trailer access.

**Cockaponset SF.**

- ***Kim Bradley DEEP Reports:*** Cockaponset State Forest: Weber Woods Parking: I met on site at the Weber Woods parking area with Martin T on Nov. 20 2025. We reviewed the area for potential re-establishment of cut through from main road. Martin expressed concern about the turning radius issues with this proposal, and whether there are alternative options for upgrades in the location for access and sightline. We also visited and discussed an alternative of a new parking proposal for the section forest across the road from Messerschmidt Pond WMA water access. Martin T also noted that it would be beneficial to investigate any potential of acquiring 489 Stevenston Rd.
- ***Diane will follow up with Ruth to ask Kim for a date to meet with her and Martin regarding the possible parking areas for horse trailers and to view site(s) for a campground..***
- **Naugatuck State Forest:** Parking lot to be expanded to allow horse trailer access  
*Diane will follow up with Kim for meeting with her and Jeff Dery, Unit Supervisor, Jared Rice (Black Rock SP) and cc Jeremy Hall, to look at the proposed parking area to be reconstructed to allow horse trailer parking access.*
- **Goodwin State Forest:** Update needed on parking for horse trailers  
*Diane will contact DEEP Matt Quinn & Eric Gileau, Eastern District Operations Supervisor*
- **Uniform DEEP Policy for safe bridges** to be built that will accommodate horses/emergency vehicle or water crossings that can be designed with minimal impact.

- Campsites available to equestrians in various parts of the state (Machimoodus & Cockaponset first locations)
- Uniform DEEP Policy for proper footing put down for multiple use (stone dust)
- Signage needed at our Parks and Forests

- **Kim Bradley DEEP Reports:** CT DEEP Signage Policy: An internal trail signage policy for CT DEEP has been internally accepted and with some minor additions will move toward acceptance. The Trail Etiquette sign recommended by Horse Council is included. Signage printing is required. Trail Safe Passing Plan - [PowerPoint Presentation](#)

- **“Passive Recreation” definition** does not include horses: ( Either list or change to non-motorized)
- **Discussion on DEEP policy on Land Acquisition.**

*Diane will follow up on the two above goals with Lindsay Suhr Land Acquisition and Management Office Director – DEEP and to include Larkin Bridle trail access*

#### Follow up:

- **Ruth Strontzer’s report: Higganum Meadow WMA:** – Where they had brush hogged has grown back up and there appears to have more grass than invasive plants, However the untouched portions just continue to worsen. The entire meadow needs to be mowed. Given the location and scope of the meadow I don’t think a controlled burn is possible. Mowing it consecutive years will help knock down the invasive plants. \* Discussion on Danielle Borrell’s earlier report that she made regarding using goats to address the issue.

**Kim Bradley Response:** A letter of complaint/suggestion to the DEEP Deputy Commissioner Mason Trumble and cc DEEP Commissioner Katie Dykes, and Justin Davis.

*Diane asked Danielle to work on letter of complaint/suggestion that the meadow is not properly mowed or maintained regularly and ask that the DEEP follow the guidelines already established to maintain and restore grasslands. And to include a previous letter/report suggesting utilizing goats. Diane will contact Ruth to help out with this historical area and how it was previously maintained*

- **Machimoodus / Sunrise State Park:**

Start conversations of possible dog area with Ray Knoop and Friends of Machimoodus due to ongoing issues with loose dogs. September 15, 2025 injury to horseback rider caused by dog . CHC had mentioned in previous meeting that DEEP consider setting aside a large designated area for dogs to be let loose in confined area.

**Sunrise** - Meadow field (old airplane landing strip) is very overgrown with invasives It needs a controlled burn or to be brush hogged.

Kick rail boards installed on bridges.

*Can possibly include going to Paugussett the same day?*
- **Cockaponset State Forest: Possible trailer parking, campsite** to review the area with John G and Martin to discuss trailer parking and camping. *Follow up discussion on access to Weber Woods and Kick rail boards installed on bridges.*

**NOTE:** CHC will continue discussion of a possible site for a horse camp and bridges being repaired or new bridges to be built in the future that can also be addressed in the CT Trail Plan that will be revised.

## Horse Owner's Corner- Timely Tips – How do I make sure the barn is safe?

### Horse Owner's Corner- Timely Tips – How do I make sure the barn is safe?

Dr. Jenifer Nadeau, UConn Equine Extension Specialist and CHC Education Chair

Safety first! That was drilled into me as a young horse handler and rider and I am grateful for it. Although most injuries with horses happen while riding a horse, horse owners and enthusiasts should strive to keep the barn as safe as possible as well since an accident can happen at any time. A recent study found that more than 38% of horse related injuries occurred at home, with 11.7% of injuries occurring in the pasture, 7.5% in the barn and 0.8% in the round pen.

Although we tend to think mainly of barn fires or other weather issues as a source of injury to horses, they can also be injured in the barn when there are no weather issues.

Common ways people can be injured in the barn is by being kicked or stepped on and injuries from a lead rope, lunge line or rein. There are many ways we can prevent these injuries in the barn. We will focus on these aspects: keeping aisles clear and safe, properly maintaining facilities and having a safe area to wash the horse. A person may be kicked or stepped on if there is inadequate space for them to move away when a horse spooks or acts out due to fear. Injuries that arise from using a lead rope lunge line or rein generally happen when someone wraps their hand in the rope, lunge line or rein. This can result in constriction, sprains or being dragged. Never wrap anything attached to a horse or other animal around any part of you ever!! Keeping aisles clear and safe is very important:

- Never allow people to bring motorized vehicles, bikes, scooters, or hoverboards into the barn. These can result in the horse becoming frightened and getting tangled in these items or the horse spooking and landing on a foot or knocking a person over. If the barn is a therapeutic riding place, horses should first be desensitized to such equipment BEFORE it comes into the barn.
- Avoid cluttering the aisle with tack trunks, storage bins, tools and chairs. Keep them in a tack room out of the way, for example.
- Make sure aisles are large enough, 10-12 feet wide is recommended
- Aisles should have non-slip footing
- Eaves should be at least 10-12 feet high to allow for clearance
- Riding in the barn should be prohibited
- Ensure that stalls prevent the horse from putting its head in the aisle which could lead to a horse or person from being bitten
- Make sure that stall side racks for bridles, halters or saddles are constructed so that a passing horse does not get caught on them (making them rounded or collapsible, for example)
- Keep trash cans away from horse traffic areas
- Have adequate lighting for the aisles and stalls

Here are some suggestions for properly maintaining facilities:

- Have a perimeter gate that can be closed

- Make sure the parking areas are maintained for winter and do not develop ruts or holes that could lead to a person or horse being injured
- Make sure all gate latches work properly
- If stall doors slide, make sure they fit firmly into the tracks and cannot come out of them which could result in a horse getting its hoof or leg caught
- If stall doors swing, make sure they stay open once they are opened, because the door could hit the horse and cause it to spook or run forward which could lead to them running into the person leading them
- Make sure partitions are constructed to prevent a horse getting a hoof caught (less than 4 inches from ground)
- Make sure partitions are strong enough to withstand a kick by a horse (1 3/4 inch minimum thickness, hardwood preferred)
- Use wood of a fire-retardant type
- Be sure all electrical wiring is enclosed in conduit and up to code
- Have a safety breaker on all electrical outlets
- Have protective covers on outlets and wall switches
- Ensure that wires to radios, fans or fence chargers are protected from horses, rodents and water
- Avoid using extension cords, especially for space heaters which can increase risk for fire
- Install smoke alarms and check the batteries regularly
- Have fire extinguishers available throughout the barn; check with your local fire department for proper placement. A rule of thumb states that there should be a fire extinguisher 50-75 feet from any location in your barn.
- Check and/or recharge fire extinguishers on an annual basis
- Have adequate ventilation for human and animal health, including the hay loft especially if hay is stored there
- Make sure that windows are made of non-breakable material and protect them from horse access with bars, slats or screens
- Check for heat in hay bales after storage

Here are some suggestions for the wash rack:

- Make sure the floor is non-skid
- Post that horses should not be tied during bathing
- Keep all light fixtures out of reach of a rearing horse
- Prevent clutter in the wash rack
- Keep electrical outlets and switches near the wash rack protected from water
- Feed the hose from overhead rather than under foot to prevent entanglement or tripping
- Have adequate drainage
- Locate the wash rack away from heavy traffic areas

Safety should be top of mind for all horse owners and enthusiasts. Although horses can be unpredictable, there are many things that can be done to keep horses and humans safe. By keeping these tips in mind, you should be able to help ensure your barn is a safe haven for all. I hope that you have fun with your horse this winter. Stay safe!
